NO STALL-HOLDER APPLICANT MAY PARTICIPATE IN THE PASIFIKA VIBES FESTIVAL 2023 ("THE FESTIVAL") HELD AT PINE RIVERS SHOWGROUNDS, 757 GYMPIE RD, LAWNTON, UNLESS THIS INDEMNITY FORM HAS BEEN COMPLETED AND SIGNED BY THE STALL-HOLDER APPLICANT OR THE PERSON WHO SIGNED THE FESTIVAL STALL-HOLDER APPLICATION FORM ("THE STALL-HOLDER APPLICATION"), AND CANNOT PRESENT A VALID PUBLIC LIABILITY INSURANCE COVER CERTIFICATE OF CURRENCY ("PLI") FOR SIGHTING BY A REPRESENTATIVE OR ITS AGENTS OF PASIFIKA VIBES FESTIVAL 2023 AND ITS ORGANISERS PASIFIKA FAMILIES INC. ("THE ORGANISERS") ON EVENT DAY, MONDAY 1ST MAY 2023.

Terms and Conditions:

I agree that if, in the opinion of the Organisers, or its agents, or its representatives, an emergency has arisen and medical treatment is deemed necessary, the Organisers, or its agents, or its representatives shall have the authority to consent to such medical treatment, including surgical intervention, on behalf of myself or any member of my organisation, business, or trading entity.

I confirm, having been advised at the time of leading up to, at the time of, or at the time of post-signing of the Stall-Holder Application, that PLI was stipulated as a requirement for holding a stall on event day. I acknowledge that if a valid PLI could not be presented or sighted, this waiver/indemnity agreement would be required for signing.
